IAATI Australasian Branch History

The Australasian Branch of IAATI was formally founded in 1993 by Sergeant Susan Maxwell of the Queensland Police Service and Senior Constable Craig Petterd of the Australian Federal Police. Both were forensic vehicle identification examiners for their respective law enforcement agencies. Prior to the advent of IAATI in Australia police forensic practitioners and auto theft detectives around Australia did already know and liaise with each other in an informal and ad-hoc manner. There was however very little or no interaction with professionals in the insurance industry, private investigation industry or other related areas of Government in Australia let alone in New Zealand.

The origins of the bid for the formation of the Australasian Branch can be traced back to 1991 when Sue Maxwell was awarded the Courier Mail Police Scholarship for that year. The aim of her scholarship was to provide funding to travel to North America, Japan and Canada to research areas of vehicle theft prevention, identification of stolen vehicles and to obtain reference data for identification number stampings. As she was already a member of the International Branch of IAATI, her funding also allowed for her to attend the International IAATI seminar in Saint Pauls Minnesota in that year, 1991. At this seminar she was invited to speak at the International Police Panel and delivered a presentation about auto theft issues and practices in Australia at the time. Also During her visit she toured the FBI facilities and networked with other auto theft investigators and vehicle examiners while in the US.

As a consequence of the quality of the International Seminar and the contacts she made there she contacted Craig Petterd, a fellow vehicle examiner with the Australian Federal Police and discussed with him the feasibility of starting a branch of IAATI in Australia. Both agreed that it was something that should be done.

The following year in 1992, Sue Maxwell and Craig Petterd travelled overseas at their own expense and attended the International IAATI Seminar in Toronto Canada. At this seminar thev met with existina International Branch Office bearers and discussed the possibility of forming a branch of IAATI in Australia.

She strongly believes that a lot more people should apply for the scholarship, describing it as a "once in a lifetime opportunity".

SUSAN'S STUDY TOUR

The Courier-Mail Police Scholarship for 1991 was awarded to Sergeant Susan Maxwell of the Scientific Section at Police Headquarters. Susan has been stationed at the Scientific Section since 1980 and has specialized in the field of vehicle identification. The aim of her Scholarship was to research areas of vehicle theft prevention, identification of stolen vehicles, and to obtain reference data for identification number stampings.

Susan left Australia on 13 August and travelled to San Francisco having a two hour stop-over in Japan. In San Francisco she inspected the San Mateo Crime Laboratory. "Even though this is a Country Laboratory it was well organised with a

very good quality assurance program," said Sue. The lab dealt with fingerprints, biological and chemical analysis, arsons, stolen vehicles, crime scene examination and ballistics.

The next stop was at Saint Paul in Minnesota in America's Mid West for the 39th Seminar of the International Association of Auto Theft Investigators of which Susan is a member. The six-day conference was attended by delegates from all over the United States, Canada, England, Sweden, Japan and South Africa.

Susan had been selected to represent Australia on the International Panel and spoke to over 400 delegates on the car theft problem in Australia. Workshops were held on subjects such as Harley Davidson Identification and Theft Prevention Programs.

Susan found that there was very good liaison between the many Police Departments, Insurance Companies, the

National Automobile Theft Bureau (N.A.T.B.) and other organizations. "I found our level of professionalism here in Brisbane to be equal to any of the places I visited overseas and our facilities to be superior" said Susan. However in many cases she found the overseas facilities with better resources than ours have here.

After the I.A.A.T.I. Seminar, Susan flew to Washington D.C. where she spent two days with the F.B.I. studying alternative serial number restoration techniques such as magnetic particle and electrolytic etching techniques. The F.B.I. had also arranged visits to the Firearm and Toolmarks Unit, Explosives Unit, Chemistry Toxicology Unit and other F.B.I. Laboratory Units. She inspected the National Automobile Altered Numbers File, the Reference Firearms Collection consisting of over 3,000 weapons, the Standard Ammunition File and the National Automotive Paint File which


helps to determine the make and model of vehicles involved in hitrun cases.

She then flew from Washington D.C. over Alaska to Japan, where she inspected the facilities and the "electrolytic polishing" technique for the recovery of serial numbers at the National Research Institute of Police Science in Tokyo. Other techniques demonstrated were Automated Landmark Identification for Ballistics and the ignition mechanism of electric wiring.

She also visited three assembly plants in Japan to inspect identification number stamping procedures. First was the Toyota Motor Corporation at Toyota City, where even an earthquake became part of the agenda! Next was the Oye Assembly Plant of Mitsubishi Motors in Nagoya. The final plants to be inspected were the Kawasaki Motorcycle Assembly and Engine Plants in Akashi. Susan arrived back in Australia in September.

Upon receiving a positive response from the International board both Craig and Sue made contact with their own law enforcement agencies as well as the remaining law enforcement agencies in Australia requesting support for the proposal. Approval was given by International Branch to found a local Australasian Branch Chapter and a charter document was readied for the occasion although considerably more work needed to be done.

Following this, a small group of existing Australian based International IAATI members and other interested parties in Australia and New Zealand were invited to a formation meeting in May 1993, in Canberra, Australia. People in attendance agreed to establish the Branch and commence taking the steps to formally bring the new Branch into existence at a Foundation Meeting set for later that year.

An interim Committee was elected at that formation meeting, as follows:

President: Craig Petterd
Vice-President: Susan Maxwell
Secretary: Eddie Challenger
Treasurer: Russell Rowell

Although a formation committee existed the Australasian Branch still did not exist at this point. This small committee had to do all of the work necessary to plan and organise the inaugural foundation meeting and meet all legal requirements to form an association including achieving the minimum number of members.

Endless hours were spent by both Craig and Sue in cold contacting, in person and by mail, all the people, organisations and corporations they could think of in Australia and New Zealand that might potentially have an interest in auto theft issues and advised them of the event and encouraged involvement.

In September 1993 the first Branch foundation meeting was held, in Canberra. The new Branch was fortunate to have the International President of IAATI, Mr. Jean-Claude Cloutier, in attendance. Branch member Mr. John Bennett was appointed as the first Editor of the Branch Newsletter (subsequently named the *Vehicle Investigator News*)



Eighty-five people from a wide variety of organisations attended the first founding general meeting and became members of the new branch of IAATI. Many of these were representatives of vehicle and parts manufacturers, insurance companies, government departments, law enforcement agencies etc. Sixteen committee members were voted in along with Craig Petterd as the inaugural president and Susan Maxwell as the Vice President

In the days following the meeting approximately thirty vehicle identification examiners and auto theft investigators from law enforcement agencies around Australia and New Zealand attended a vehicle identification workshop in Canberra. This was not actually an IAATI event however the networking possibilities that came with the establishment of the organisation were utilised at this early stage.

In 1994 the Branch held its first Annual Training Seminar, in Sydney. Then International President Mr. Ken McKenzie attended and officially presented the Branch with its Charter document.

In 2006 the Australasian Branch achieved a further milestone that it had been contemplating for a number of years, namely to hold an annual seminar in New Zealand and expand the branch's offering to potential delegates in New Zealand who may previously have been unable to travel to Australia to attend seminars. The 2006 seminar was held in Wellington, New Zealand and attracted 108 delegates. Approximately 62 of these were New Zealand residents. The event was a success as more New Zealanders joined the branch and the New Zealand representation of the branch committee increased. This had the follow on effect in subsequent years to provide more exposure and relevance to New Zealand issues and further seminars in that country.








In 2006 Maurice J. Kerrigan and Associates began to liaise and work with Australasian Branch of IAATI to build a framework for the implementation of an accreditation program for auto theft investigators and technical experts in Australia.

Later in 2006 the Australasian Branch held its first one day seminar in Sydney. The initiative was for the purpose of providing an opportunity for Australian based members of the Branch who were unable to travel to overseas locations, an opportunity to see an abridged selection of the presentations that had been delivered at the annual seminar earlier in the year in New Zealand. This initiative was well attended and well received. Approximately 40 delegates from around Australia attended.

In 2008 the Australasian Branch hosted the International Seminar for the second time, this time in Sydney. Two hundred and sixty one delegates from 21 countries (7 were first time countries) attended making the event the largest IAATI seminar held in Australia to date.

In 2008 at the International Seminar in Sydney the Australasian Branch of IAATI was able to announce and launch its new Accreditation Program. This was the culmination of many years of debate and discussion within IAATI that had taken place over at least the preceding ten years concerning the development and implementation of an accreditation program.

In 2009 the Branch again attended New Zealand for its annual seminar holding it on this occasion in Auckland. The event was again well patronized by delegates primarily from both Australia and New Zealand and again well received.

Later in November 2009 the Branch continued with its policy of holding a one day seminar in Australia in the years when the main seminar was held in New Zealand. This again was an abridged offering of the speakers who addressed the main seminar in Auckland. This event was also a milestone in Australasian Branch history because it was the first time the Branch had held a seminar in Perth.

Due to the success of the Perth one day seminar a follow-up one day training seminar was again held in Perth in 2010. This time it was an event solely for the purpose of catering to the interests of local delegates in Western Australia.

A further milestone was reached in 2012 when a one day seminar was held in Auckland, New Zealand. Although seminars had been held in New Zealand before, this seminar was organized solely by New Zealand based committee members. The seminar agenda catered for the interests of local delegates. The seminar was well received by attending delegates.

2013 marked the Branch's 20th Anniversary and to celebrate an extra special Annual Training Seminar was held at the Royal Pines Resort at the Gold Coast. The celebrations commenced a golf day on Sunday 14 April followed by a 3 hour birthday BBQ dinner. The classroom session on 15 and 16 April included five international keynote speakers:

The event was all the more special as not only was it attended by Founding President Craig Petterd and founding Vice President Susan Maxwell but also by Mr. John O'Byrne in his role as the International President of IAATI.

Later in April IAATI sponsored a one-day training session in Auckland that was organised by the NZ Police.

The year 2015 was also a milestone year for the Australasian Branch because it was the first time a full three day annual Seminar was held in Perth. An annual seminar had never been held in the city for a number of logistical reasons. Some of these included the time differences, the lack of major stakeholders in the state, the costs to travel there and the lower levels of membership in Western Australia. After considerable debate at committee level the decision was made to hold the 2015 seminar in Perth. Feedback from delegates who attended indicated it was one of the best ever seminars held by IAATI. The speakers were of a very high standard and the post seminar feedback survey gave the practical workshop components a rating of 4.7 out of 5. The workshop sessions involved practical demonstrations and instruction from industry experts in the fields of Forensic Vehicle Identification, Vehicle Fire Examination and Forensic Crash Investigation.

The workshops were held off site at Technology Park at Bentley. The demonstration on the usefulness of crash data information downloaded from vehicles, followed by how that data can



be interpreted to create a virtual image of the crash in progress was highly valued by the delegates. The demonstrations continued with interpreting accident damage on vehicles to assist conducting accident investigations. There were also demonstrations on engine number restorations, electrical wiring harness fires, vehicle fires and displays by the WA Department of Transport, Driver & Vehicle Services.

Whilst workshops had been held at IAATI seminars previously the depth and breadth of topics covered definitely raised the bar for future seminars.

In 2016 we returned to Melbourne where we hosted 2 days of classroom presentation at the Langham Southbank and a third day offsite at the Automotive Centre of Excellence at the Docklands. During the third day we also visited Lindsay Fox's classic Car Collection.

Awards

In 2000 the Australasian Branch commenced its annual Awards program where it introduced three award categories and called for nominations. Nominations for two of the awards were open to anyone and were not restricted to existing IAATI members. The requirement was however that the nomination had to be for an endeavour that occurred in the geographical territory covered by the Branch. The awards were therefore open to any nominations from Australia, New Zealand and South East Asia.

The categories offered initially were:

- · Investigation of the Year
- · Outstanding Contribution to the Reduction of Auto Theft
- · Member of the Year

Each year a panel of guest judges for each category assessed each nomination and declared an overall winner. The winners were announced and awarded their Trophies at the Annual seminar dinner.

The award categories were expanded to include the DataDot Award in 2005 and the Investigation of the year award category was split into Insurance Investigation of the Year and Law Enforcement Investigation of the year in 2008.





In 2012 the Award category of Presidents Award was introduced replacing the narrower Outstanding Contribution to the Reduction in Vehicle Theft Award. This new category was designed to expand on the previous category by recognising achievement in the detection, prevention and/or investigation of auto crime.

In 2016 Branch created a new award recognising the role play by Forensic and other supporting services and a Travel Scholarship
